

## Georgia Bio Legislative Report April 5, 2019 Session Recap

## **GENERAL UPDATE:**

The 2019 legislative session concluded with Sine Die on Tuesday, April 2. All bills that successfully made it through this year will now head to the Governor's desk for his approval. Governor Kemp has 40 days to sign or veto legislation. Those bills that failed to make it through this year are still alive for passage in the 2020 session.

This legislative session was characterized by new leadership in the Governor and Lt. Governor's office, as well as 40 freshman legislators. Georgia Bio will continue to monitor legislation over the next 40 days and keep members informed as bills are signed into law. Georgia Bio will also be working with our members this year on our legislative priorities going into the 2020 session.

### **BUDGET UPDATE**

On Thursday March 28<sup>th</sup>, the Senate and House adopted the Conference Committee report for HB 31, the General Appropriations budget for FY 2020. Georgia Bio is happy to report that our total asking amount of \$323,000 for our rural teacher training program made it through the legislative process. The bill is now headed to the Governor's desk.

### **BILL MOVEMENT**

This session the Georgia Generally Assembly passed legislation that would establish step therapy protocols for patients, provisions for the licensure of genetic counselors, pharmacy anti-steering and transparency act, regulations and licensure of pharmacy benefits managers, the authorization to submit a Section 1115 waiver request to the United States Department of Health and Human Services Centers for Medicare and Medicaid Services, and modernizing telemedicine policy in Georgia. ### HB 30 - Supplemental appropriations; State Fiscal Year July 1, 2018 - June 30, 2019

Bill Author: Rep. David Ralston (R-Blue Ridge)

**Bill Status: PASSED** 

**Summary:** HB 30 provides appropriations for the State Fiscal Year beginning July 1, 2018 and ending June 30, 2029. These appropriations fund the operation of the State government and its departments, boards, bureaus, commissions, institutions, and other agencies, for the university system, common schools, counties, municipalities, and political subdivisions, for all government activities, projects, and undertakings authorized by law.

## HB 31 - General Appropriations; State Fiscal Year July 1, 2019 - June 30, 2020

Bill Author: Rep. David Ralston (R-Blue Ridge)

Bill Status: PASSED

**Summary:** HB 31 provides appropriations for the State Fiscal Year beginning July 1, 2019 and ending June 30, 2020. These appropriations fund the operation of the State government and its departments, boards, bureaus, commissions, institutions, and other agencies, for the university system, common schools, counties, municipalities, and political subdivisions, for all government activities, projects, and undertakings authorized by law.

Importance: Monitoring

## HB 63 - Insurance; Health Benefit Plans to Establish Step Therapy Protocols

**Bill Author:** Rep. Sharon Cooper (R - Marietta)

**Bill Status: PASSED** 

**Summary:** HB 63 is the same bill from the 2018 session and is a compromise from all parties involved and establishes a process for when it is medically appropriate to override a step therapy protocol for patients.

Importance: SUPPORT

#### HB 99 - Insurance; Provide for Modernization and Updates

Bill Author: Rep. Richard Smith (R - Columbus)

**Bill Status: PASSED** 

**Summary:** HB 99 purposes to modernization and update provisions regarding health insurance for

purposes of conformity.

Importance: Monitoring

#### **HB 166 - Genetic Counselors Act**

Bill Author: Rep. Deborah Silcox (R - Sandy Springs)

Bill Status: PASSED

**Summary:** HB 166 provides provisions for the licensure of genetic counselors, continuing education requirements, renewal requirements and duties and powers of the Georgia Composite Medical Board with respect to genetic counselors.

Importance: Monitoring

## **HB 233 - Pharmacy Anti-Steering and Transparency Act**

Bill Author: Rep. David Knight (R - Griffin)

**Bill Status: PASSED** 

Summary: HB 233 prohibits pharmacies from engaging in certain practices, requires pharmacies to file

an annual disclosure statement among other requirements.

Importance: Monitoring

## HB 321 - Health; hospital Medicaid financing program; extend sunset provision

Bill Author: Rep. Jodi Lott (R - Evans)

**Bill Status: PASSED** 

Summary: HB 321 aims to extend the sunset provision for hospital Medicaid financing program to June

30, 2025.

**Importance: Monitoring** 

## HB 323 - Insurance; Administration of Claims by Pharmacy Benefit Managers

Bill Author: Rep. David Knight (R - Griffin)

Bill Status: PASSED

**Summary:** HB 323 relates to the regulation and licensure of pharmacy benefits managers for purposes of administration of claims, prohibiting certain activities, and to provide an effective date and applicability.

Importance: Monitoring

## **HB 514 - Georgia Mental Health Reform and Innovation Commission**

**Bill Author:** Rep. Kevin Tanner (R - Dawsonville)

Bill Status: PASSED

Summary: HB 514 creates the Georgia Mental Health Reform and Innovation Commission.

Importance: Monitoring

## SB 106 - "Patients First Act"

**Bill Author:** Senator Blake Tillery (R - Vidalia)

Bill Status: Senate Date Signed by Governor on March 27, 2019

**Summary:** SB 106 authorizes the Department of Community Health to submit a Section 1115 waiver request to the United States Department of Health and Human Services Centers for Medicare and Medicaid Services. The Patients First Act is a step toward lowering insurance premiums, enhancing access to quality care, and improving health outcomes in every part of our state.

**Importance: Monitoring** 

# SB 115 - "Medical Practice Act of the State of Georgia"; telemedicine licenses for physicians in other states; engage in the practice of medicine with patients in this state through telemedicine

**Bill Author:** Senator Renee Unterman (R - Buford)

Bill Status: PASSED

**Summary:** SB 115 relating to the Medical Practice Act of the State of Georgia, aims to provide telemedicine licenses for physicians licensed in other states to engage in the practice of medicine with patients in this state through telemedicine.

**Importance: Monitoring** 

#### SB 118 - Insurance; Georgia Telemedicine Act; modernize; Telemedicine Act the Telehealth Act

**Bill Author:** Senator Renee Unterman (R - Buford)

**Bill Status: PASSED** 

**Summary:** SB 118 aims to modernize the Georgia Telemedicine Act, to rename it to the Telehealth Act. The bill provides the definitions of telemedicine and telehealth and prohibits insurers from requiring insureds to use telemedicine and for pay equity for health care providers using telemedicine.

**Importance: Monitoring** 

## SB 121 - Prescription Drug Monitoring Program Data Base; length of time prescription information is retained from two years to five years; increase

**Bill Author:** Senator Larry Walker (R - Perry)

Bill Status: PASSED

Summary: SB 121 relates to the prescription drug monitoring program data base, to increase the length

of time that prescription information is retained in the data base from two years to five years.

Importance: Monitoring

## SB 195 - "Prescription Drug Benefits Freedom of Information and Consumer Protection Act"

**Bill Author:** Senator Chuck Hufstetler (R - Rome)

Bill Status: House Receded from Amend or Sub on April 2, 2019

**Summary:** SB 195 provides consumer protections and freedom of information regarding prescription

drug benefits.

Importance: Monitoring
